This can be obtained from the installing heating and cooling dealer. No incentive will be awarded based on SEER rating listed on the HVAC dealer bid specifications, promotional material of dealer, manufacturer or any other source than AHRI.

Homeowners must complete a request form and provide proof of purchase (invoice or receipt) to receive any 2018 incentive.

Deadline to apply for 2018 Rebate Program is Dec. 15, 2018.
